

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of the sport; conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something else.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of the competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of his breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

Qualifications for the Triple Crown Versatility Challenge

(Qualify and/or place in any three classes, across a minimum of two NSS Events)

Agility: Qualifying score in any agility class offered.

Obedience: Qualifying score in any obedience class offered.

Rally: Qualifying score in any rally class offered.

Conformation: Best of Breed, Best of Opposite Sex, Select Dog/Bitch, a Judge's Award of Merit or by making the cut in the Best of Breed competition, Placement in any regular or non-regular conformation class. (Please note: in Stud Dog and Brood Bitch classes, placements are awarded only to the parent dog, not to any of the representative offspring.) Placement in any Puppy or Veteran Sweepstakes class also qualifies.

Field: Qualifying score in any Working Dog Test (WD, WDX, WDQ).

Example 1:

"Fido" is entered in Rally Novice A, Rally Advanced A, Open Dog in conformation, and the WD for field. Fido qualified in Rally Novice A and placed third in Rally Advanced A. In Open Dog, he did not get a placement. Since his first two "goals" were both in Rally, and he failed to get a placement in Conformation, he does not meet the Triple Crown Challenge until the field, when he passes the WD.

Example 2:

"Ripple" is entered in Veteran Obedience, 8+ Year-Old Bitch in Veteran Sweeps, Veteran Bitch 8-10 Years in Conformation, and the WD for field. She qualifies in obedience, is second in her Sweeps class, and goes first in her Veteran conformation class. She's already met the Triple Crown Versatility Challenge before she hits the field!

EXHIBITOR INFORMATION:

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs must be ready for judging. Neither the Club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

The show giving Club, the Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property while at or on the show grounds, or in transit to or from the show. And furthermore assumes no responsibility for injury to children.

The hosting club will exercise every precaution for the safety of dogs exhibited, but it must be understood that neither the club, site or show secretary will be responsible for any injury, damage, or loss. It is understood that all dogs at this show are in the care and custody of the owners or owner's agents during the entire show weekend.

There shall be no drilling or intensive /abusive training of dogs on the show grounds.

Dogs must be in control at all times. This includes the use of Flexi leashes.

Exhibitors are required to clean up after the dogs that they are exhibiting or which are under their care or control. CGC Test

Canine Good Citizen Test

The AKC's Canine Good Citizen Program is designed to recognize dogs that have good manners at home and in the community. This rapidly growing nationally recognized program stresses responsible dog ownership for owners and basic training and good manners for dogs. All dogs that pass the 10 step CGC test are eligible to receive a **CGC Title** from the American Kennel Club. To be eligible for testing, dog must be a minimum of 6 months of age.

TDI Test

Therapy Dog International, Inc. Test

Therapy Dogs International (TDI^\circledast) is a volunteer organization dedicated to regulating, testing and registration of therapy dogs and their volunteer handlers for the purpose of visiting nursing homes, hospitals, other institutions and wherever else therapy dogs are needed. To belong to Therapy Dogs International (TDI^\circledast) all dogs must be tested and evaluated by a Certified TDI Evaluator. A dog must be a minimum of one (1) year of age and have a sound temperament. Each dog must pass a TDI temperament evaluation for suitability to become a Therapy Dog. The test will also include the evaluation of the dog's behavior around people with the use of some type of service equipment (wheelchairs, crutches, etc.).

Junior Showmanship Classes

NOVICE JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

MASTER CLASS - (effective date of January 1, 2012) For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) first place wins in an Open Class, with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1-October 31 of the following year. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department

Each dog exhibited in Junior Showmanship must be owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother including the corresponding step and half relations or by a member of the Junior Handlers household.

Bitches in season are not eligible to be shown in Junior Showmanship Classes.

At a Specialty show, each dog must be of the breed for which the show is held.

A dog that has been rejected - dismissed or excused by the veterinarian for the protection of the other dogs at the show or for the protection of the dog excused, may not be handled in Junior Showmanship.

Each dog handled in a regular Junior Showmanship Class must be entered and shown in one of the breed classes at the show, or must be entered for Junior Showmanship only. However, a dog that must be withdrawn for good and sufficient reason, such as a bitch in season or a veterinarian's excuse may be replaced by another dog meeting the same ownership requirements. Such substitution must be requested in writing stating the reason for the substitution and must be accompanied by an official AKC entry form.

BRED BY EXHIBITOR REQUIREMENTS: All dogs entered in the Bred-By Class must be individually registered with the AKC, the person handling the dog must be a breeder of record and an owner or co-owner of the dog

BEST OF BREED COMPETITION: Effective for all shows held on or after July 1, 1980, dogs which according to their owner's records have completed the requirements for a Championship after the Closing of Entries for this show, but whose Championships are unconfirmed, may be transferred from one of the Regular Classes to the Best of Breed or Variety Competition, provided this transfer is made by the Show Secretary at least one-hour prior to the start of the judging at this show. (American Kennel Club Rule, Chapter 11, Section 6)

Neutered Dogs & Spayed Bitches are allowed to compete in Veteran classes at Independent Specialties.

FIELD TRIAL DOG CLASS – Open to Dogs that have received a JAM or better at an AKC licensed or member field trial.

FIELD TRIAL BITCH CLASS – Open to Dogs that have received a JAM or better at an AKC licensed or member field trial.

HUNTING DOG CLASS – Open to Dogs that have achieved the AKC Junior Hunter, Senior Hunter or Master Hunter Titles.

HUNTING BITCH CLASS – Open to Dogs that have achieved the AKC Junior Hunter, Senior Hunter or Master Hunter Titles.

NON-REGULAR (Additional) CLASSES – Involving Multiple Dog Entries

As the judge's decision in the Non Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

STUD DOG CLASS – For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record in Best of Breed Competition, but MUST be entered in the Stud Dog Class the Get MUST be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plush the additional class fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

BROOD BITCH CLASS – Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

BRACE CLASS – Two dogs of the same Breed and must have at least one common owner and presented by a maximum of two handlers. If more than one Brace is entered by the same owner, the dogs compromising each Brace must be so designated, "Brace #1, "Brace #2, etc.

AWARDS OF MERIT

The judge may at their discretion, recall into the ring up to six dogs/bitches to receive a Judge's Award of Merit. This award is reserved for those quality animals the judge feels are worthy of final consideration for Best of Breed.

Effective January 1, 2010 CHAPTER 11. SECTION 1.

No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration.
