**Start Time:** 8 am for WD and WDQ. WDX start 8:30 am (*to be finalized after Aug 4 deadline*) Check-in time after 7:15 am, Test dog at 7:50 am and a short discussion with the Judges. All stakes run at the same time.

**Fees:** ACC Members - \$55 for each stake, Non-Members \$65 (special rules for non-members, view on ACC website and WD info). You must be approved as a member by the entry deadline to use the member fee. Non-Members can run each dog in only one stake - the WD, X or Q. They would sign an ACC membership application that day (if not before). You have 30 days only to submit your membership application with fee for ACC Board approval. If approved as a member, you would then receive your passing certificate from the ACC WD Program Director. A Non-Member can run one time only as a non-member. See the Special rules for Non-Contention dogs with prior titles Pre-Entry Only

**Entry Deadline:** August 4, 2021 - 8 pm - no phone or email entries – waive signature on overnight couriers

**Entry Forms:** Use the attached Entry Form (*it can be typed on and printed out*). Use a separate entry form for each dog & each stake. Mail entries/check payable to ACC: Jane Pappler, 7 Easton Way, Southampton, NJ 08088

**\*\*Note** – Bitches in season cannot run and are not to be aired on the grounds. Refunds are available. See the instructions in the WD Rules. Please notify us in writing in advance if you need to cancel an entry.

**Running Order:** a Draw and Running Order will be posted on the website by 8-16-21. Please download your copy of the typed running-order or include your email address and we will email it to you by 8-16-21. Catalog Copies will not be available at the WD.

**Results and Photos:** Reports and group photos will be published in the ACC Bulletin and on the show website.

**Rules for the WD/X/Q:** Copies of all rules, Guidelines. Procedures and Entry Form are available on the ACC website at <http://www.amchessieclub.org> on the WD/X/Q pages or the show specialty website at <https://amchessieclub.org/specialties2/show21pennsylvania/index.htm> . Call or email the chairman Jane Pappler or the Program Director Laurea Griggs with any questions. Take time to read through the requirements and procedures in advance. This will help you and your dog to be successful and not fail due to handler error.

**Requirements:** (see complete info on the printouts listed on the ACC website)

WD: back to back singles on land and water

WDX: a double on land and a double on water, dogs must be steady and deliver to hand

WDQ: a double on land, a land blind, a water blind and a combination triple with two birds in water and one on land. Dogs must be steady and deliver to hand. Dogs will be off lead from the holding blind to the line.

What to Bring: Water for you and your dogs, shade equipment, bug spray, lawn chair, whistle, flat buckle collar and leash, boots, and your lunch. Pickup all trash and take it with you.

Lunch: local "General Store and Deli" within 6 miles of Rebel Ridge on Rt 71 (Red Lion Rd) , Bear, DE.

Directions: leaving Rebel Ridge, turn left, go 1.3 miles to stop sign. Turn left, pass the Delaware Veterans Memorial Cemetery to stop sign. Turn right, go 2.2 miles to "general Store" on left just before the railroad tracks..

Volunteers needed: Marshals, bird boys, grounds person for parking and signs, test dogs, person to Pop/throw and live bird Shooters, possibly need a valid hunting license and orange to wear. Ask the chairman.

For all concerned - Please take time to read through the requirements and procedures in advance before the test date. This will help you and your dog to be successful and not fail due to handler error. One important rule to remember is "you cannot send your dog until you hear the Judge call your number". The judges will go over the basic rules with everyone quickly before the start of the stake and you can ask a few questions then if needed. Please have your dogs aired and ready to go before it's your turn to be called to the holding blind. All dogs must be kept on lead when not running and must be kept back by the vehicles where they cannot see any of the tests being run. No dogs permitted near the line or gallery. Make sure your dog has had gun fire, white coats, and ducks when

training. Park in designated areas only. Do not walk around in the gallery, avoid loud talking and do not wear white. Any of these can be very distracting to the running dogs and the contestants

**Smoking is NOT Allowed** on the grounds of Rebel Ridge Farms or on grounds leased by Rebel Ridge farms. Absolutely **NO use of Alcohol** at any time while on these grounds.

Rebel Ridge Club House: Port-o-potty located here. Check-in upon arrival here. Ribbons will be given out at conclusion of stakes here.

Directions: Driving time from the WD site in MD to the Wyndham Hotel in York, PA is 1 hr 55 min, 83 miles.

Directions from Elkton, MD- Take Rte. 213 South approximately 3 miles from the intersection of Route 40 and 213. Turn left onto Elk Forest Road at the flashing light. Take an immediate right onto Knights Corner Road. Go 0.4 miles. Turn left onto Woods Rd. Go 0.7 miles. Turn left into Rebel Ridge Farms Inc.

Directions from Newark, DE - Take Rte. 896 South. Turn left onto Rte. 71. Go 0.7 miles. Turn right onto Chesapeake City Road. Go 2.3 miles. Turn right onto Steele Road (which becomes Woods Road in MD). Go 1.4 miles. Turn right into Rebel Ridge Farms, Inc

Food: a local "General Store and Deli" within 6 miles of Rebel Ridge on Rt 71 (Red Lion Rd) , Bear, DE. Directions: leaving Rebel Ridge, turn left, go 1.3 miles to stop sign.
