Annual Board Report: 2023-2024

It has been the pleasure of the Board to serve the members and foster growth within our community. In addition to our standard operating procedures and decisions, the Board has diligently worked to bring transparency and consistency to our members. We have also achieved several exciting goals. The following is a summary of the accomplishments the Board made over the past year.

In October 2023, the implementation of Membership Works was initiated. This feature introduced a Members Only area on the website, which includes an up-to-date online Membership Directory. Members can manage their profile in the Manage Membership area. Membership Works also allows for ease of membership renewal. Other benefits include timely posting of Board and Member minutes, job openings with detailed descriptions and requirements, access to the Bulletin Archive, and participation in Polls. It also allows us to offer online donations and reservations for club events. This exclusive area is accessible only to members and requires login credentials.

Creation and implementation of the Volunteer Policy. This initiative aimed at fostering transparency between the Board and members regarding volunteer applications. Under this policy, all applications are received by the Volunteer Coordinator, who then distributes them to the Board and prospective committee members in a timely manner. Applicants receive an acknowledgment of receipt and are kept informed of the Board's decision once an appointment is made. This policy has streamlined the application process and ensured that members are well-informed throughout.

From June 14 to August 15, 2024, the Board conducted a Member Survey. The survey included general questions aimed at gathering constructive feedback from members. The goal was to identify areas where member services could be improved. You can view the results of the survey in the November/December 2024 Bulletin.

In December 2024, the Health Survey was launched, marking the culmination of extensive efforts that began in 2019. The initiative was spearheaded by the Health Survey ad hoc committee, chaired by Mitchell Horowitz, with Veronica Mercer and Linda Apuzzo (former member) as members. The committee undertook thorough research and development of the survey, eventually presenting it to the 2020-2021 Board of Directors. After several meetings between board members and the committee, the survey's content and questions were finalized. Thanks to Mitchell Horowitz's expertise and resource contributions, the survey was successfully completed in an online format. It was then made available to members and the public in December 2024.

In summary, these additions have significantly improved the club's operations and provided enhanced benefits to its members.





HEALTH COMMITTEE ACC RECOMMENDED HEALTH TESTS

For All Breeding Stock

The ACC Board of Directors strongly recommends that all breeding stock be free of Hip/Elbow Dysplasia, Progressive Retinal Atrophy (PRA) in addition to all hereditary eye diseases, Exercise Induced Collapse (EIC), and Degenerative Myelopathy (DM) - tested Normal or otherwise. The above health statement was proposed by our ACC Health Committee then approved by the ACC Board of Directors on September 11, 2016, (ACC Board Motion 16:39).



American Chesapeake Club CODE OF ETHICS

Love and respect of the Chesapeake Bay Retriever is implicit in membership in the American Chesapeake Club. Therefore, all members agree to foster the goals set forth in the Code of Ethics.

RESPONSIBILITIES OF MEMBERS

- a. Read and familiarize yourself with the American Chesapeake Club Breed Standard for the Chesapeake Bay Retriever that is approved by the American Kennel Club. Support and abide by the rules of the American Chesapeake Club and the American Kennel Club.
- b. Appreciate the unique nature of the Chesapeake Bay Retriever and try to develop the characteristics this dog has inherited through selective breeding (intelligence, desire to mark and retrieve with style, love of water, and keen scenting ability).
- c. Assume the responsibility of proper feeding, maintenance, health care, and training at all times.
- d. Always conduct yourself in a manner which will reflect credit on yourself and the breed. Refrain from public criticism or malicious degrading of others or their dogs, whether in person, on social media, or otherwise.
- e. Never knowingly sell or place a Chesapeake Bay Retriever with unethical persons or those who would not provide proper and humane care to the dog. Refuse to sell any Chesapeake Bay Retriever to any pet shop or to any wholesale dealer in dogs.
- f. Should you become aware of the mistreatment, abuse, or need for relocation of any Chesapeake Bay Retriever, make every effort to be of assistance by notifying the breeder of the dog involved, the local authorities, and helping in any other way in which you are able.

RESPONSIBILITIES OF BREEDERS/ BROOD BITCH/STUD DOG

The ACC Board of Directors strongly recommends that all breeding stock be free of Hip/Elbow Dysplasia, Progressive Retinal Atrophy (PRA) in addition to all hereditary eye diseases, Exercise Induced Collapse (EIC), and Degenerative Myelopathy (DM) - tested Normal or otherwise.

- a. Do not breed Chesapeake Bay Retrievers that are not registered by the American Kennel Club or by kennel clubs recognized by the American Kennel Club.
- b. Strive in each breeding to improve the breed according to the ACC Breed Standard. Conscientiously plan each breeding based on the parents of the appropriate temperament, appearance, and other desirable qualities.
- c. Be aware of genetic defects which can be harmful to the breed. When breeding, endeavor to select animals that will reduce the incidence of genetic problems while enhancing the positive attributes and abilities of the breed. Be open with all persons interested in the welfare of the Chesapeake Bay Retriever and discuss possible physical or temperament defects in your own stock.
- d. Do not breed any bitch which is not mature (never before the second heat) and in good health. Do not allow puppies to go to their new homes until at least seven weeks of age.
- e. Act responsibly toward all puppies produced by your brood bitch or stud dog for the lifetime of the puppies. (Recommend that the breeder encourage the owner to contact the breeder if the owner can no longer keep a dog at any time in the dog's life).
- f. Understand that written contracts are strongly recommended for all transactions, such as sales, guarantees, co-ownerships, breeding rights agreements, bitch leases, stud services, etc. Keep accurate records and pedigrees and give new owners registration papers or forward registration papers as soon as possible.
- g. Use and promote the use of the American Kennel Club nonbreeding registration on pet quality puppies which are sold or placed by you.

American Chesapeake Club CBR DATABASE

As the keepers of the breed and the parent club's mission to providing information regarding the health and history of the breed to our members and the public, the breed database is more than a health database, it combines titling and health test results from all sources. In addition to the OFA results we permit owners to enter results from any testing lab as a free public service. Owners and breeders can submit new dogs, test results, personal notes, and photos of their dogs.
